## **Treasurer and Budget Status Reports**

Reports presented by Deb thru August 31, 2021. Reports attached and distributed prior to meeting. Opening Balance \$19,907.15 Revenue \$1,854.10 Expense \$2,830.25 Closing Balance \$18,931.00 Income has included memberships, donations and tee shirt sales. \$900 from a Hudson River Bank Trust grant and \$100 from Bank of Greene County. Jerry moved to approve the Treasurer's Report, Jake seconded, passed. Jerry Callahan noted that we had not formally accepted his resignation as Treasurer or formally instated Deb Shakotko as the new Treasurer. # **Membership Report**

Ron reports 161 members: 63 individuals, 84 families, 14 sponsors There were 20 new individuals, 9 new family memberships and 1 new sponsor. Tabling at the Kinderhook Farmer's Market continues to have been good promotion and public relations.

# **Training and Maintenance Committee Report**

Ron reports that the mower crews have completed 8 full mowing circuits of the full path. String trimming continues. Ron continues to note that some foliage is tall and overhanging the trail above the reach of trimmers and will need addressing. A tractor with a sickle bar or flail arm attachment has been requested of the Greenway. This equipment may incur the need for a taller storage shed. Mike Mescia from the audience said he was a landscaper and wishes to volunteer for trail maintenance. Jake notes that new volunteers need to be scheduled for safety training.

### **Strategic Planning Committee Report**

This task is now finished. Ron distributed the Public Version. Copy on file. We now need to populate the various committees enumerated in the Plan. Please volunteer.

#### Web Development Report

Lee reports the committee met 9/26, 30 and 31. Solasus has the framework and a substantial amount of material for the web. There are catch-up bits.
